This amount of interest shall be remitted along with the charges due (however no interest is collectable for Security Deposits)
- 3. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.
 - 4. You are also requested to comply the following:-
 - a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under LCR 2(b, ii:
 - ii) Te construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demalished;
 - ii, In cases of Special Buildings Ground Developments, a professionally qualified Architect Registered with Council of architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furn shed. In cases of Multistoreyed buildings, both qualified architect and a qualified structural Engineer who should also be a class-I Licensed Surveyor shall be associated and the above informations to be furnished.

- Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the canctioned plan. Similar report shall be sent to hadra- Metropolitan Development Authority when the building has reached upto plinth level and the eafter every three months at various stages of the construction/development of the upproved plan. The Licensed Jurveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner developer has been cancelled or the construction is carried out in deviation to the approved plan;

- v) On completion of the construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be occupied until a completion cettificate is obtained from Mad as He ropolitan Development Authority.
- vi) While the applicant makes application for service connection such as electricity, Water supply, Sewerage he should enclose, a copy of the completion certificate issued by MML along with his application to the concerned becartment/Board/Agency:
- vii) When the site under reference is transferred by way of sale/lease or any other means to any persons before completion of the construction, the party shall inform MMLA of such transaction and also then ame and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the planning permission.
- viii) In the open space with in the site, trees should be planted and the existing trees perserved to the extent possible.
- in) If there is any false statement, suppression or any misrepresentations of acts in the application, planning permission will be liable for cancellation and the development made, if any will be treated as unauthorised.
- x) The new building should have mosquito proof ovarhead tanks and wells:
- xi) The sanction will be void abinitio, if the conditions mentioned above are not complied with:
- xii) Rainwater cons reation measures notified by MMDA should be adhe ed to strictly.

- (a) Undertaking (in the format prescribed in Annexure- XIV to DCR, A copy of it enclosed in Rs. 10/- stamp paper duly executed by all the lands owner, GPA holders, builders and promoters separately. The undertakings shall be duly attested by a Notary Public.
- (c) Details of the proposed development duly filled in the format enclosed for display at the site. Display of the information at site is compulsory in cases of Multi-storeyed buildings, special

buildings and Group Developments.

The issue of planning permission depend on the compliance/ fulfilment of the conditions/payments stated above. The acceptance by the Authority of the Prepayment of the Development charge and other charges etc., shall not entitle the person to the planning permission but only refund of the Development charge and other charges (Excluding Scrutiny fee) in cases of refusal of the permission for non - compliance of the conditions stated above or any of the provisions of DCR, which has to be complied before getting the planning permission, or any other reason provided the construction is not commenced and claim for refund is made by the applicant.
