  - ii) Te construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demalished;
  - ii, In cases of special Buildings Ground Developments, a professionally qualified Architect Registered with Council of architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furn shed. In cases of Multistoreyed buildings, both qualified architect and a qualified structural angineer who should also be a class-I Licensed Surveyor shall be associated and the above informations to be furnished.

- ii / A report in writing shall be set to Madras Metropolitan Development Authority by the Archit of Class-I Licensed Surveyor who supervises the construction just be form the commencement of the erection of the building as per the canctioned plan. Similar report shall be sent to ladra metropolitan Development Authority when the building has reached up to plinth level and the eafter every three months at various stages of the construction/development of the tipping that the work so far completed is in accordance with the approved plan. - ix) If there is any false statement, suppression or any misrepresentations of acts in the application, planning permission will be liable for cancellation and the development made, if any will be treated as unauthorised.
- x) The new building should have mosquito proof overhead tanks and wells:
- xi) The earction will be void abinitio, if the conditions mentioned above are not complied with:
- xii) Rainwater conservation measures notified by MMDA should be adhe ed to strictly.
