 - ii) I a construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demalished;
 - ii, In cases of special Buildings Ground Developments, a professionally qualified Architect Registered with Council of architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furn shed. In cases of Multistorayed buildings, both qualified architect and a qualified structural Engineer who should also be a class-I Licensed Surveyor shall be associated and the above informations to be furnished.

- A report in writing shall be sent to Madras iii) Metropolitan Development Authority by the Architect/ class-I Licensed Surveyor who sup rvises the construction just before the commencement of the erection of the building as per sanctioned phan.
