 - ii) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demalished;
 - ii, In cases of special Buildings Ground Developments, a professionally qualified Architect Registered with Council of architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Multistoreyed buildings, both qualified architect and a qualified structural Engireer who should also be a class-I Licensed Surveyor shall be associated and the above informations to be furnished.

- Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the srection of the building as per the canctioned plan. - vi) While the applicant makes application for service connection such as electricity, Water supply, Sewerage he should enclose a copy of the completion certificate issued by MMLA along with his application to the concerned Department/Board/Agency:
- vii) When the site under reference is transferred by way of sale/lease or any other means to any persons before completion of the construction, the party shall inform MMDA of such transaction and also then ame and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the planning permission.
- viii) In the open space with in the site, trees should be planted and the existing trees pereseved to the extent possible.
- ix) If there is any false statement, suppression or any miscepresentations of acts in the application, planning permission will be liable for cancellation and the development made, if any will be treated as unauthorised.
- x) The new building should have mosquito proof overhead tanks and wells:
- xi) The sanction will be void abinitio, if the conditions mentioned above are not complied with:
- xii) Rainwater conservation measures notified by MMDA should be adhe ed to strictly.
