 - (a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under DCR 2(b) II:-
 - (E) The Construction shell be undertaken as per the sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished.
 - (ii) In cases of Special Buildings/Group Developments, a professionally qualified Architect Registered with council of Architects as Class-I Licensed surveyor shall be associated with the construction work till it it completed. Their names/addresses and consent letters shouldbe furnished. In cases of Multistoreyed building, both qualified Architect and a qualified structural Engineer who should also be a class-I Licensed Surveyor shall be associated, and the above informations to be furnished.

- iii) A report in writing chall be sent to Madres Metropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervisor the construction just before the commencement of the erection of the building as per the sanctioned plan. The newly appointed Licensed Surveyor/Architect shall also confirm to MMDA that he has agreed for supervising the work under reference and intimate the stage of construction at which he has taken over. No construction shall be carried on during the period intervening between the sait of the previous Architect/Licensed Surveyor and entry of the new appointes;
 - v) On completion of the construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Madres Metropolitan Development Authority;
 - vi) While the applicant makes application for service connection such as Electricity, Water Supply, Severage he should enclose a copy of the completion certificate issued by MMDA along with his application to the concerned Department/Board/Agency;
 - vii) Then the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform NNDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to x these conditions to the Planning Permission.

- viii) In the open space within the site, trees should be planted and the existing trees preserved to the extent possible;
 - ix) If there is any false statement, suppression or any misrepresentation of acts in the application, planning permission will be liable for cancellation and the development made, if any will be treated as unauthorized:
 - x) The new building should have morcuto proff overhead tan're and wells;
 - xi) The ranction will be void abinitio, if the conditions mentioned above are not compled with;
- xii) Rain water conservation measures notified by MNDA should be adhered to strictly.
 - b) undertaking (in the format prescribed in Annexure-XIV) to DCR, a copy of it enclosed) in R.10/- Stamp Paper duly executed by all the land owners, GPA holders, builders and promoters separately. The undertakings shall be duly attested by a Notary Public.
 - c) Details of the proposed development duly filled in the format enclosed for display at the site. Display of the information at site is compulsory in cases of Nulti-Storeved Buildings, Special Buildings and Group Developments.
- 5. The insue of Planning Permission will depend on the compliance/fulfilment of the conditions/payments stated above.
