 - (h) The Construction shall be undertaken as per the sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished.
 - (ii) In cases of Special Buildings/Group Developments, a professionally qualified Architect Registered with council of Architects as Class-I Licensed surveyor shall be associated with the construction work till it it completed. Their names/addresses and consent letters shouldbe furnished. In cases of Multistoreyed building, both qualified Architect and a qualified structural Engineer who should also be a class-I Licensed Surveyor shall be associated, and the above informations to be furnished.

- iii) A report in writing shall be sent to Madres Metropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to Madras Metropolitan Development Authority when the building has reached upto plinth level and thereafter every three months at various stages of the construction/ development certifying that the work so far completed is in accordance with the approved plan. No construction shall be carried on during the period intervening between the exit of the previous Architect/Licensed Surveyor and entry of the new appointes;
 - v) On completion of the construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Madras Metropolitan Development Authority;
 - vi) While the applicant makes application for service connection such as Electricity, Water Supply, Severage he should enclose a copy of the completion certificate issued by MMDA along with his application to the concerned Department/Board/Agency;
 - vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform MVDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to x these conditions to the Planning Permission.

- viii) In the open space within the site, trees should be planted and the existing trees preserved to the extent possible;
 - ix) If there is any false statement, suppression or any misrepresentation of sors in the application, planning permission will be liable for cancellation and the development made, if eny will be treated as unauthorized;
 - x) The new building should have morcuto proff overhead ten're and wells;
 - xi) The sanction will be void abinitio, if the conditions mentioned above are not compled with;
 - xii) Rain water conservation measures notified by MNDA should be adhered to strictly.
