The planning permission application and revised plan received in the reference first and third cited for the construction of Basement + Ground + Mezzanine + III Floor Shops, Office and Residence 2 blocks at No. 21, Malathy Avenue, T.S.No. 136 part, Lattice Bridge Road, Thiruvanniyur, Madras-41 has been approved subject to the conditions incorporated in the reference third cited.

2. The applicant has remitted the necessary charges in Challan No. 64939, dated 23.3.95 accepting the conditions stipulated by MMDA vide in the reference fourth cited and furnished Bank Guarantee for a sum of Rs. 1,50,000/- (Rupees one lakh and fifty thousands only) towards Security Deposit for building 21.3.2000.

3. As per the Madras Metropolitan Water Supply and Sewerage Board letter cited in the reference fifth cited with reference to the sewerage system the premises has to submit the necessary sanitary application directly to Metro Water and only after due sanction he can commence the internal sewer works.

In respect of water supply, it may be possible for Metre Water to extend water supply to a single tap for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 l ped. In respect of requirements of water for other uses, the premises has to ensure that he can make alternate arrangements. In this case also, the premises should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and Septic Tanks are hermetically sealed with properly protected vents to avoid mosquito menace.

4. Two sets of approved plans, numbered as Planning Permit No. B/19620/412/A-6/95, dated 7.8.95 are sent herewith. The Planning Permit is valid for the period from 7.8.1995 to 6.8.2000.
