The Planning Permission Application/revised plan received in the reference 1st cited for the additional construction of Ground Floor + 2 Floors of residential Building at 106, Pulianthope High Road, in R.S.No.1749/5, vepery has been approved subject to the conditions incorporated in the reference 2nd cited and the roof slab projection shown for demolition should be done before the completion of the building.

2. You have remitted the necessary charges in Challan No.73898 dated 12-4-'96 accepting the conditions stipulated by MMDA. vide in the reference 3rd cited.

In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and Septic Tanks are hermetically sealed with properly protected vents to avoid mosquito menace.

4. One copy/set of approved plans numbered as Planning Permit No.B/20763/198/96 dated 24-5-'96 are sent herewith. The Planning Permit is valid for the period from 24-5-'96 to 23-5-'99.

5. This approval is not final. You have to approach the Madras Corporation for issue of building permit under the respective Local Body Acts, only after which the proposed construction can be commenced.


