  - ii) In cases of Special Buildings Ground Developments, a professionally qualified Architect Registered with Council of architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Multistoreyed buildings, both qualified architect and a qualified structural Engineer who should also be a class-I Licensed Surveyor shall be associated and the above informations to be furnished.

- ii , A report in writing shall be sent to Madras Metropolitan Davelopment Authority by the Architect/Class-I Dicensed Surveyor who supervises the construction just before the commencement of the section of the building as per the anctioned plan.
