The planning permission application received in the reference first cited for the construction/development of Ground Floor + 2 Floor Residential building at T.S.No.42, Block No.58, No.8, Plot No.C-758, 50th Street, Ashok Nagar, Madras-83 Kodambakkam, Madras-83 has been approved subject to the conditions incorporated in the reference second cited.

2.
