 - 4. You are also requested to comply the following:-
 - 'a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under LCR 2(b) ii:
 - ii) Te construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demalished;
 - ii) In cases of Special Buildings Ground Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Multistoreyed buildings, bot! qualified architect and a qualified structural Engineer who should also be a class-I Licensed Surveyor shall be associated and the above informations to be furnished.

- ii , A report in writing shall be sent to Madras Metropolitan

 - v) On completion of the construction the applicant shall intimats AMDA and shall not occupy the building or permit it to be occupied until a completion cettificate is obtained from Madras Metropolitan Development Authority.
 - vi) While the applicant makes application for service connection such as electricity, water supply, Sewerage he should enclose a copy of the completion certificate issued by NMLA along with his application to the concerned Department/Board/Agency:
 - vii) When the site under reference is transfer ed by way of sale/lease or any other means to any persons before completion of the construction, te party shall inform MMDA of such transaction and also tename and address of the persons to whom the site is transfer ed immedia ely after such tensaction and shall bind the purchaser to these conditions to the planning permission.
 - viii) In the open space with in the site, trees should be planted and the existing trees perserved to the extent possible.
 - ix) If there is any false statement, suppression or any mismepresentations of acts in the application, planning permission will be liable for cancellation and the development made, if any will be treated as unauthorised.

 - xii) Rainwater cons-rvation measures notified by MMDA should be adhe ed to strictly.
