- a) Furnish the letter of your acceptance for the following conditions stipuleted by virtue of provisions available under DCR 2(b)ii:
 - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished;
 - ii) In cases of Special Buildings/Groups Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Murii-Storeyed Buildings, both qualified Architect and ma qualified Structural Engineer who should also be a Class-I Licensed Surveyor should be associated, and the above informations to be furnished;

- iii) A report in writing shall be sent to Madres Metropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan.
