 - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished;
 - ii) In cases of Special Buildings/Groups Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Multi-Storeyed Buildings, both qualified Architect and a a qualified Structural Engineer who should also be a Class-I Licensed Surveyor shall be associated, and the above informations to be furnished;

- iii) A report in writing shall be sent to Madres Metropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the huilding as per the sanctioned plan. - vi) While the applicant maker application for service connection such as Electricity, Water Supply, Severage he should enclose a copy of the completion certificate issued by MMDA along with his application to the concerned Department/Board/Agency;
- vii) When the site under reference is transferred by may of sale/lease or any other means to any person before completion of the construction, the party shall inform NDA of such transaction and also the nome and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to x these conditions to the Planning Permission.

 - ix) If there is any false statement, suppression or any migrepresentation of acts in the application, planning permission will be liable for cancellation and the development made, if eny will be treated as unauthorised;

 - xi) The canction will be void abinitio, if the conditions mentioned above are not compled with;
 - xii) Rain water conservation measures notified by MMDA should be adhered to strictly.
