Payments received after 30 days from the date of issue of this letter will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges lue (However no interest is collectable for Security Deposits).
- 3. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.
  - 4. You are also requested to comply the following:
  - (a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under DCR 2(b)ii:
    - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished;
    - ii) In cases of Special Buildings/Group Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Multi-storeyed Building, both qualified Architect and a qualified Structural Engineer who should also be a Class-I Licensed Surveyor shall be associated, and the above informations to be furnished;

- Metro olitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to ladras Metropolitan Development Authority when the building has reached upto plinth level and thereafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan. The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan;
  - iv) The owner shall inform hadras Metropolitan Development Authority of any change of the Licensed
    Surveyor/Architect. The newly appointed
    Licensed Surveyor/Architect shall also confirm
    to MIDA that he has agreed for supervising the
    work under reference and intimate the stage of
    of construction at which he has taken over.
    No construction shall be carried on during the
    period intervening between the exit of the
    previous Architect/Licensed Surveyor and entry
    of the new appoints:
    - v) On completion of the construction the applicant shall intimate TaDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Madras II. tropolitan Development Authority;
  - vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he should enclose a copy of the completion certificate issued by NIDA along with his application to the concerned Department/Board/Agency;
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform LDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the Planning Permission.
- viii) In the Open space within the site, trees should be planted and the existing trees preserved to the extent possible;

- ix) If there is any false statement, suppression or any misrepresentation of facts in the application, Planning Permission will be liable for cancellation and the development made, if any will be treated as unauthorised;
  - x) The new building should have moscuito proof overhead tanks and wells;
- xi) The senction will be void abinitio, if the conditions mentioned above are not complied with;
- xii) Rain water conserv tion measures notified by ITDA should be adhered to strictly.
- (b) Undertaking (in the format prescribed in Annexure-XIV) to DCR, a copy of it enclosed) in Rs. 10/- Stemp Paper duly executed by all the land owners, GPA holders, builders and promoters separately. The undertakings shall be duly attested by a Notary Public.
- (c) Details of the proposed development duly filled in the format enclosed for display at the site. Display of the information at site is compulsory in cases of Multi-

storcycd Buildings, Special Buildings and Group Developments.
