

It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed with proper protected vents to avoid mosquito menance.

Regarding Water Supply it may be possible to provide piped water supply to the premises for drinking and cooking purpose only when water main is laid in that road. Till such time the party has to make his/her own arrangements.

4. Two copy/Set of app oved plans, numbered as C/PP/61/895 Planning Permit No. 18639 dated: 4.95 is sent herewith. The Planning Permit is valid for the period from - 4.1995 to - 4.1998

5. This approval is not final.
