3. As per the MMWSSB letter cited in the reference 'a with respect to the sewer connection for the proposed building may be possible when a public sewer is laid in that above said address. Till such time the party has to make their own arrangements having disposal without nuisance by providing septic tank of suitable size with

upflow filter with collection samp or either by means of dispersion trench of suitable length and breadth as per guidelines of the Government of India Mannuel. It shall be ensured that all wells, overhed tanks and septic tanks are hermitically sealed with proper protected vents to avoid mosquito menance.

Regarding Water Supply it may be possible to provide piped water supply to the premises for drinking and cooking purpose only when water main is laid in that road. Till such time the party has to make his/her own arrangements.

5. This approval is not final.
