



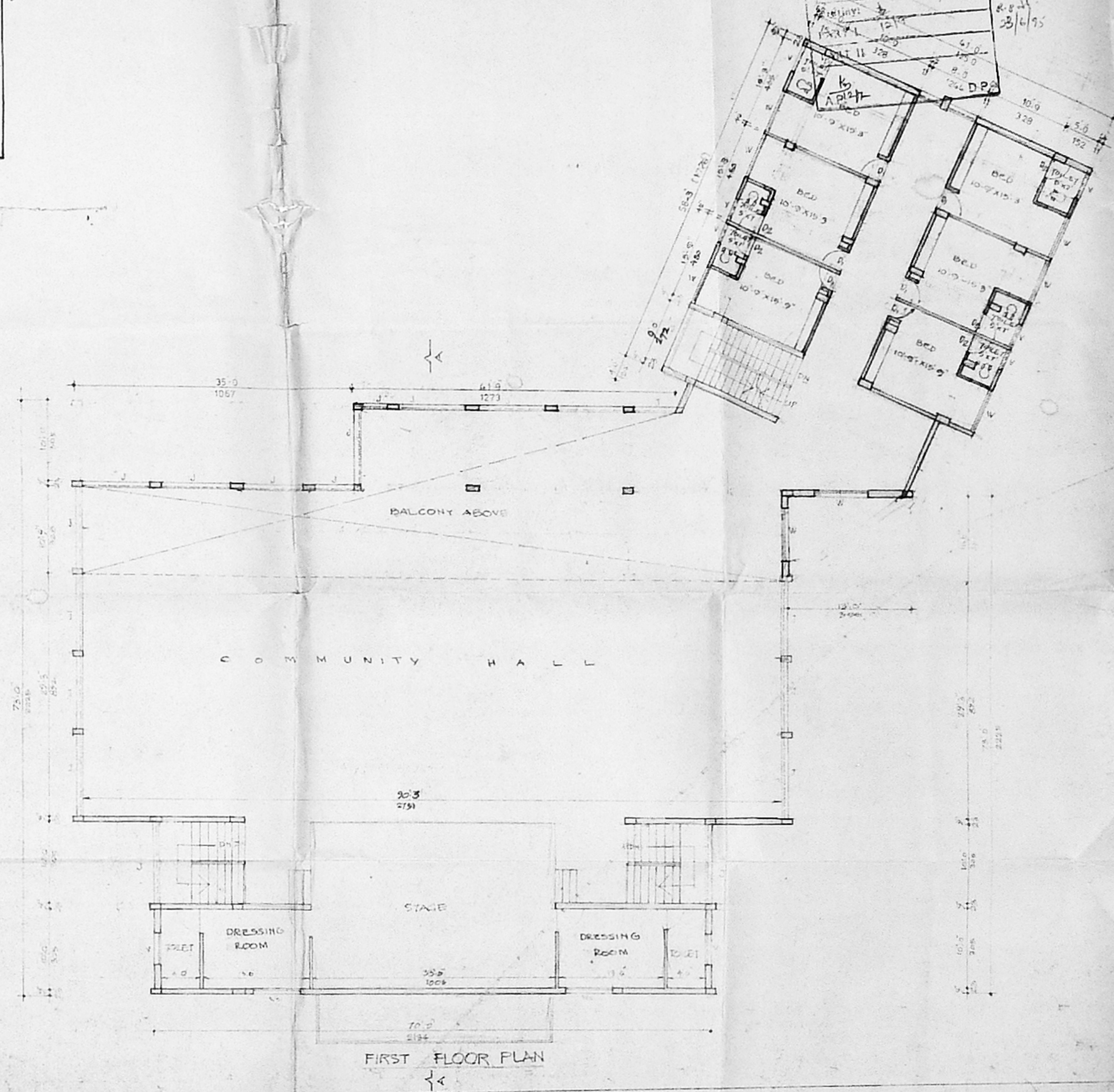
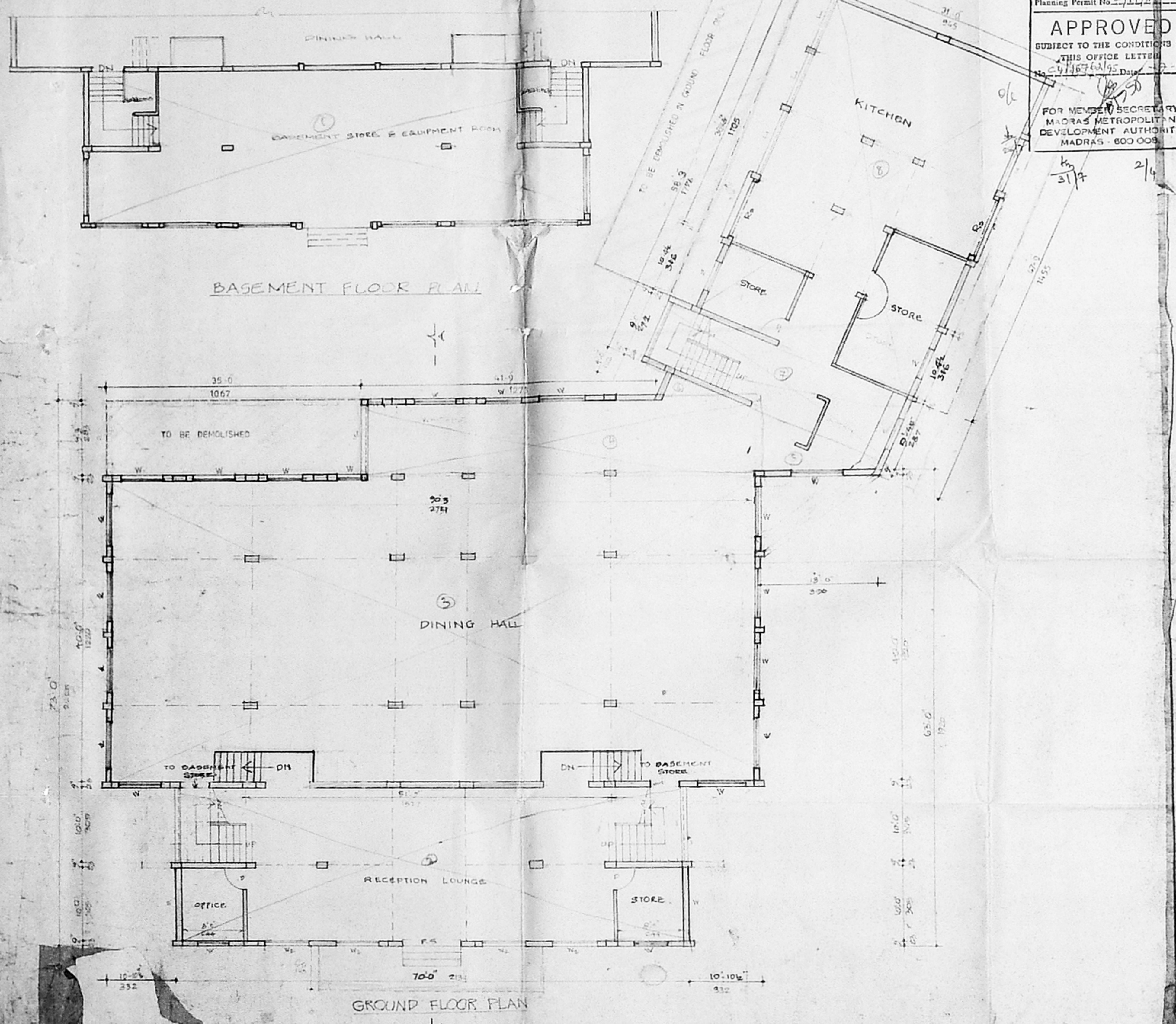
PLAN SHOWING THE PROPOSED

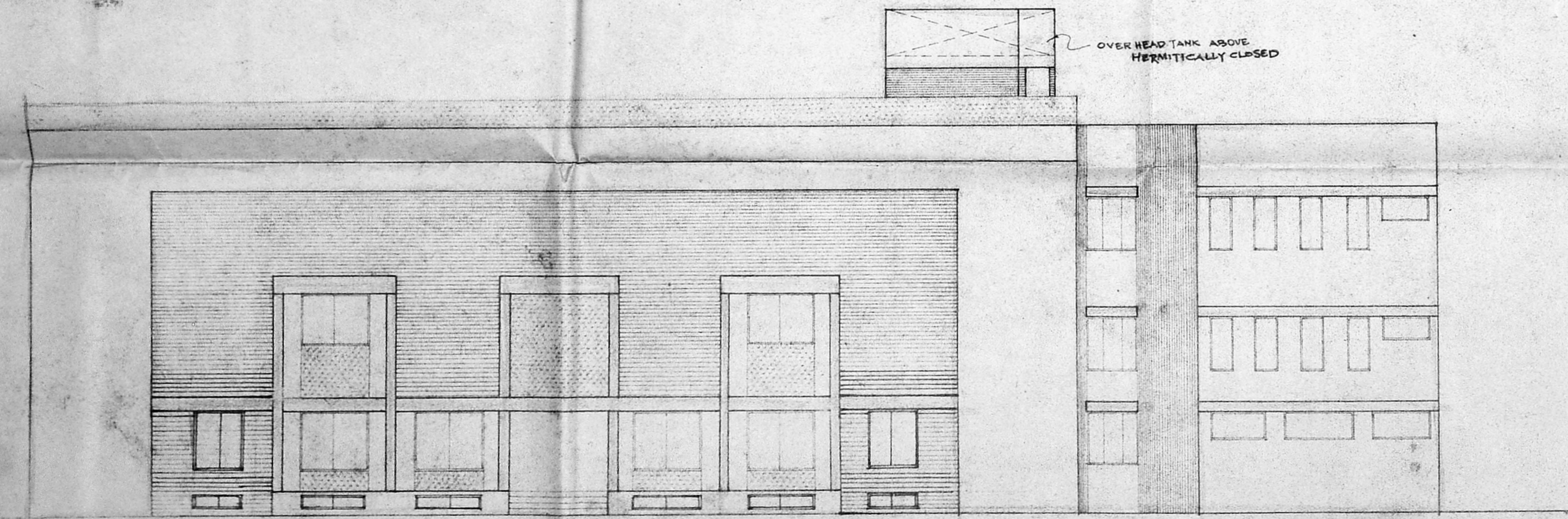

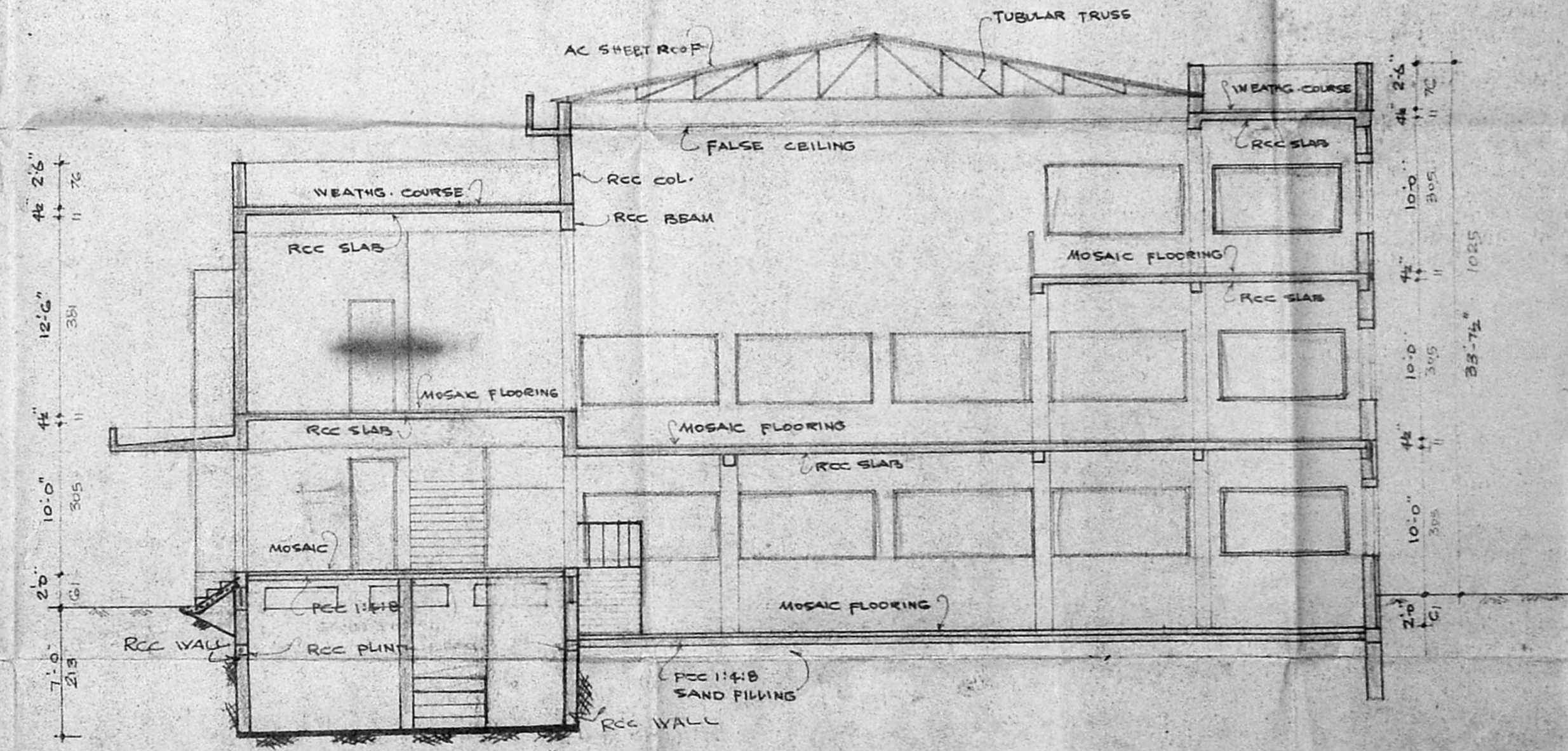

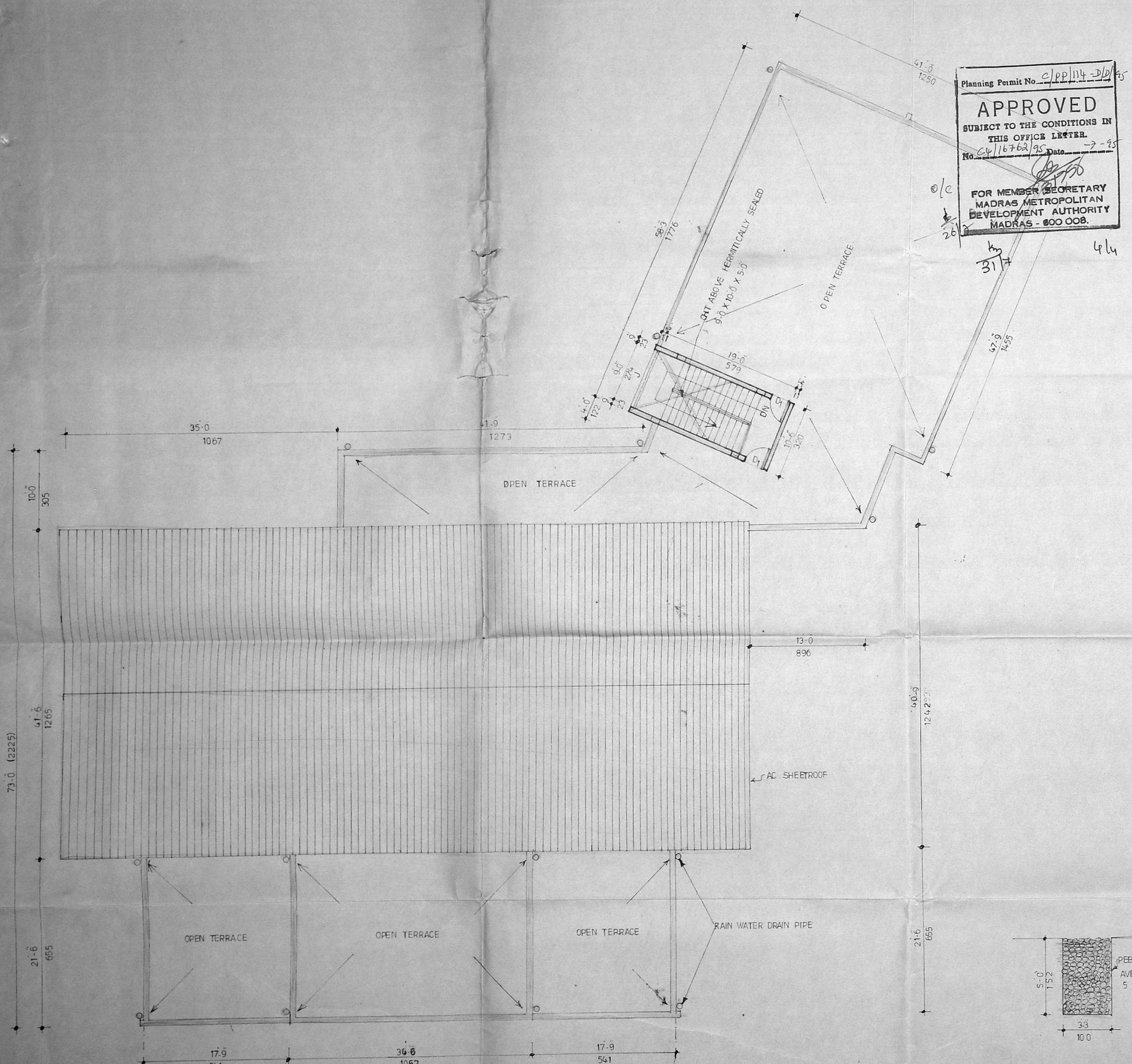
