i)	Development charge for land and building under Sec.59 of T&CP Act 1971.	Rs 200/- (Rupees Two hundred only)
ii)	Scrutiny fee	Rs 100/- (Rupees one hundred only)
iii)	Regularisation charges ..	Rs 1150/- (Rupees one thousand one hundred and fifty only)
iv.)	Open Space Reservation charges (i.e. equivalent to land cost in lieu of the space to be handed over) as per DCR 19 a (iii)	Rs 10,590/- (Rupees ten thousand and five hundred only).

2. Payments received after 30 days from the date of issue of this letter will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

3. The plans would be returned unapproved, if the payment is not made within 60 days from the date of issue of this letter.

4. You are also requested to comply the following:-
