2. The planning permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.



- a) Rain Water conservation regulations stipulated by CMDA should be adhered to strictly.


5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
