The Planning Permission application received in the

2. The Planning Permission is issued subject to the

iii) 'To pay improvement charge and open space reser-

- (x) 2 (iv) you should not demolish the common wall of the existing building
and you should demolish the remaining building after obtaining
the approval for demolition from the Local Body after ensuring
that no damage is caused to neighbour's property.

4. The approved plans are numbered as Planning Permit No. A/20511/398/96 and one copy of the same along with one copy of the planning permit are enclosed herewith for taking further action in this regard.

5. This approval is not final. The applicant has to approach the Madras Corporation/Municipality/Panchayat Union/Township/Town Panchayat for issue of building permit under the respective Local Body Acts, only after which the proposed construction can be commenced.
