 - i) The construction shall be undertaken as per sanotioned plan only and no deviation from the plans should be usde without prior sanction. Construction done in deviation is liable to be demolished;
 - ii) In cases of Special Buildings, Group Developments a professionally qualified Architect Registered

with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished.

- iii) A report to writting shall be sent to channaim etropolitan Development Authority by the Architect/Class-I Licensed) Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctibned plan Similar report shall be sent to channaim etropolitan Development Authority when the buildings is has reached upto plinth level and whereafter every three months at various stages of the construction/ development certifying that the work so far completed is in accordance with the approved plan. - xii) Rainwater conservation measures notified by CMDA should be adhered to structly;
