- a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under DCR 2(b) ii:
  - i) The construction shall be undertaken as per sanotioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demclished;
  - ii) In cases of Special Buildings, Group Developments a professionally qualified Architect Registered

with Council of Architects or Class-I Licensed Surveyor shall by associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished.

- iii) A report to writting shall be sent to change iMetropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the huilding as per the sanctioned plan Similar report shall be sent to change iMetropolitan Development Authority when the buildings is has reached upto plinth level and whereafter every three months at various stages of the construction/ development certifying that the work so far completed is in accordance with the approved plan. The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan.

- v) On completion of the construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be completed until a completion certificate is obtained from 10 kennel Metropolitan Development Authority.
- vi) While the applicant makes application for service connection such as Electricity, Water supply, sewerage he should enclose a copy of the completion certificate issued by CMDA along with his application to the concerned Department/coard, Agency:
- vii) When the site under reference is transferred by they of sele/lease or anyother means to any person before completion of the construction, the partyshall inform CMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the planning permission.

- ix) If there is any false statement, suppression or any mis representations of acts in the application, planning permission will be liable for cancellation and the development made, if any will be treated as unauthorised.

- x) The new building should have mosquito pro werhead tanks and wells;
- xi) The sanction will bebooid binitio, if the conditions mentioned above are not complies with;
- xii) Rainwater conservation measures notified by CMDA should be adhered to structly;
  - (a) Undertaken (in the format prescribed in Annexure XIV to DCR) a copy of it enclosed in E. 10/Stamp paper duly executed by all the land owner,
    GPA holders, builders and promoters separately.
    The undertakings shall be duly attested by
    a Notary Public.
  - (b) Details of the proposed development duly filled in the format enclosed for display at the site in cases of special buildings and group developments.
- 5. Theissue of planning permission depend on the compliance /fulfilment of the conditions/payments stated above. The acceptance by the Authority of the Prepayment of the Development charge and other charges etc., shall not entitle the person to the planning permission but only refund of the Development charge and other charges (excluding scrutiny fee) in cases of refusal of the permission for non-compliance of the orditions stated above or any of the provisions of DCR, which has to be complied before getting the planning permission or any other reason provided the construction is not commenced and claim for refund is made by the applicant.
