The Planning Permission application and Revised Plan received in the reference first and second cited for the construction of Ground Floor + 2 floors residential building with 27 dwelling units at T.S.No. 38/4, 39/1,2, Block No. 20 of Mambalam Village Door No. 35, Ellayamman Koil Street, West Mambalam, Madras-33 has been approved subject to the conditions incorporated in the reference.

2. You have remitted the necessary charges in Challan No. 73086, dt. 1.3.96 accepting the conditions stipulated by MMDA vide in the reference 4th cited.

3. As per the Madras Metropolitan Water Supply and Sewerage Board's letter cited in the reference 5th cited with reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro water and only after due sanction he/she can commence the internal sewer works.

In respect of water supply, it may be possible for Metro water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and Septic Tanks are hermitically sealed with properly protected vents to avoid mosquito menace.

4. One copy/set of approved plans numbered as Planning Permit No. **B/20670/105/96, dt. 19.3.96** are sent herewith. **The Planning Permit is valid for the period from 19.3.96 to 18.3.99.**

5. This approval is not final. You have to approach the Madras Corporation for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
