- 3. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.
  - 4. You are also requested to comply the following:
  - a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under DCR 2 (b) ii:
  - i) The Construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished.
  - ii) In cases of Special Buildings/Group Developments, a professionally qualified Architect Registered with Council of Architects or class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Multi-storeyed buildings, both qualified Structural Engineer who should also be a Class-I Licensed Surveyor shall be associated, and the above informations to be furnished.

- Metropolitan Development Authority by the Architect/
  class-I Licensed Surveyor who supervises the construction just before the commencement of the erection
  of the building as per sanctioned phan. Similar report
  shall be sent to Madras Metropolitan Development
  Authority when the building has reached upto plinth

No construction shall be carried on during the period intervening between the exit of the previous Architect /Licensed Surveyor and entry of the new appointee:
- v) On completion of the construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Madras Metropolitan Development Authority:
- vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he should enclose a copy of the completion certificate issued by MMDA along with his application to the concerned Department/Board/Agency.
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the perty shallinform MMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the planning permission.
- viii) In the O'en Space within the site, trees should be plented and the existing trees preserved to the extent possible:
