 - 4. You are also requested to comply the following:
 - a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under DCR 2 (b) ii:
 - i) The Construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished.
 - ii) In cases of Special Buildings/Group Developments, a professionally qualified Architect Registered with Council of Architects or class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Multi-storeyed buildings, noth qualified Structural Engineer who should also be a Class-I Licensed Surveyor shall be associated, and the above informations to be furnished.

- Development Authority by the Architect/class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per sanctioned plan. - xi) The sanction will be void abinitio, if the conditions mentioned above are not complied with;
 - xii) Rain water conservation measures notified by MMDA should be adjered to strictly.

- 5. The issue of Planning permission will depend on the compliance/fulfilment of the conditions/apyment stated above. The acceptance by the Authority of the prepayment of the development charge and other charges etc., shall not entitle the person to the Planning Permission but only refund of the Development charge and other charges (excluding Scrutiny fee) in cases of refusal of the permission for non-compliance of the conditions stated above or any of the provisions of DCR, which has to be complied before getting the planning permission or any other reason, provided the construction is not commenced and claim for refund is made by the applicant.
