 - ii) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demalished;
 - ii) In cases of special Buildings Ground Developments, a professionally qualified Architect Registered with Council of architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furn shed. In cases of Multistoreyed buildings, both qualified architect and a qualified structural Engineer who should also be a class-I Licensed Surveyor shall be associated and the above informations to be furnished.

- Metropolitan Development Authority by the Architect/

- v) On completion of the construction the applicant shall intimate MMIDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Madras Metropolitan Development Authority:
- vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he should enclose a copy of the completion certificate issued by MMDA along with his application to the concerned Department/Board/Agency.
- vii) When the site under reference is transferred by way of sele/lease or any other means to any person before completion of the construction, the perty shallinform MMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the planning permission.
