This amount of interest shall be remitted along with the charges due (however no interest is collectable for Security Deposits)
- 3. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.
 - 4. You are also requested to comply the following:-
 - a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under LCR 2(b, ii:
 - ii) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demalished;
 - ii, In cases of Special Buildings Ground Developments, a professionally qualified Architect Registered with Council of architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furn shed. In cases of Multistoreyed buildings, both qualified architect and a qualified structural Engineer who should also be a class-I Licensed Surveyor shall be associated and the above informations to be furnished.

- ii , A report in writing shall be sent to Madras Metropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just b fore the commencement of the spection of the building as per the anctioned plan. Similar report shall be sent to Madra metropolitan Development Authority when the building has reached up to plinth level and the eafter every three months at various stages of the construction development of tifying that the work so far completed is in accordance with the approved plan. - vii) When the site under reference is transferred by way of sals/lease or any other means to any persons before completion of the construction, the party shall inform MMLA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such than action and shall bind the purchaser to these conditions to the planning permission.

- ir) If there is any false statement, suppression or any misrepresentations of acts in the application, planning permission will be liable for cancellation and the development made, if any will be treated as unauthorised.
- x) The new building should have mosquito proof overhead tanks and wells:
- xi) The sanction will be void abinitio, if the conditions mentioned above are not complied with:
- xii) dainwater construction measures notified by MMDA should be adhe ed to strictly.

- (a) Undertaking (in the format prescribed in Annexure- XIV to DCR, A copy of it enclosed in & 10/- stamp paper duly executed by all the lands owner, GPA holders, builders and promoters separately. The undertakings shall be duly attested by a Notary Public.
- (c) Details of the proposed development duly filled in the format enclosed for display at the site. Display of the information at site is compulsory in cases of Multi-storeyed buildings, special buildings and Group Developments.
- 5. The issue of planning permission depend on the compliance/ fulfilment of the conditions/payments stated above. The acceptance by the Authority of the Prepayment of the Development charge and other charges etc., shall not entitle the person to the planning permission but only refund of the Development charge and other charges (Excluding Scrutiny fee) in cases of refusal of the permission for non compliance of the conditions stated above or any of the provisions of DCR, which has to be complied before getting the planning permission, or any other reason provided the construction is not commenced and claim for refund is made by the applicant.
