The planning permission application and revised plan received in the reference first and third cited for the construction of Ground Floor + 3 Floor Residential building with 7 dwelling unit at Door No.7, Raman Street, T.S.No.4861/2 T. Nagar, Chennai has been approved subject to the conditions incorporated in the reference fourth cited.

2. You have remitted the necessary charges in Challan No.77591, dated 20.9.96 accepting the conditions stipulated by CMDA vide in the reference fifth cited.

3. As per the Chennai Metropolitan Water Supply and Sewerage Board letter cited in the reference second cited with reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro water and only after due sanction she can commence the internal sewer works.

In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells ~~overhead tanks~~ overhead tanks and septic tanks are hermitcally sealed with properly protected vents to avoid mosquito menace.

4. One copy of approved plans numbered as Planning Permit No.B/24405/540/96, dated 6.12.96 are sent herewith. The Planning Permit is valid for the period from 6.12.96 to 5.12.99.
