- ii) In cases of Special Buildings, Group Developments a professionally qual fied ArchitectRegistered with Council of Architects or Class-I Licenzed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished.
- iii) A report to writting shall be sent to Madras Metropolitan Development Authority bythe Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan.
