- Furnish the letter of your acceptance for the following ornditions stipulated by virtue of provisions available under DCR 2(b) ii:
  - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished;
  - ii) In cases of Special Buildings, Group Developments a professionally qualified Architect Registered

with Council of Architects or Class-I Licensed Surveyor shall be cassociated with the construction work till it is completed. Their names/addresses and consent letters should be furnished.

- iii) A report to writting shall be sent to channai Metropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan Similar report shall be sent to channai Metropolitan Development Authority when the buildings is has reached upto plinth level and whereafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan. - v) On completion of the construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Chernai Metropolitan Development Authority.
  - vi) While the applicant makes application for service connection such as Electricity, Water supply, sewerage he should enclose a copy of the completion certificate issued by CMDA along with his application to the concerned Department/seard, Agency:
- vii) When the site under reference is transferred by tay of sale/lease or anyother means to any person before completion of the construction, the partyshall inform CMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the planning permission.

- ix) If there is any false statement, suppression or any mis representations of acts in the application, planning permission will be liable for cancellation and the development made, if any will be treated as unauthorised.

- x) The new building should have mosquito pro werhead tanks and wells;

- xii) Rainwater conservation measures notified by CMDA should be Adhered to structly;
