3. As per the MMWSSB letter cited in the reference
with respect to the sewer connection for the
proposed building may be possible when a public sewer is
laid in that above said address. Till such time the party
has to make their own arrangements h-v-ing disposal without
nuisance by providing septic tank of suitable size with

upflow filter with collection sump or either by means of dispersion trench of suitable length and breadth as per guidelines of the Government of India Manual. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

Regarding Water Supply it may be possible to provide piped water supply to the premises for drinking and cooking purpose only when water main is laid in that road. Till such time the party has to make his/her own arrangements.

4. Two copy/Set of approved plans, numbered as C/PP/133/96
Planning Permit No. 19887 dated: 26-3-96
is sent herewith. The Planning Permit is valid for the period from 26-3-96 to 26-3-1999.

5. This approval is not final. The applicant has to approach the Madrass Corporation/Municipality/Panchayat Union/Township/Town Panchayat for issue of building permit under the respective Localbody Acts, only after which the proposed construction can be commenced. A unit of the Madrass Corporation is functioning at MMDA first floor itself for issue of Building Permit.
