It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed with proper protected vents to avoid mosquito menance.

Regarding Water Supply it may be possible to provide piped water supply to the premises for drinking and cooking purpose only when water main is laid in that road. Till such time the party has to make his/her own arrangements.

4. Two copy/Set of app oved plans, numbered as C/PP/84/50 Planning Permit No. 20240 dated: 26-7-1996 is sent herewith. The Planning Permit is valid for the period from 26-7-1996 to 25-7-1999.

5. This approval is not final.
