iv) Open Space Reservation charges	Rs. 12,400/- (Rs. Twelve thousand and four hundred only)

2. The Planning Permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.

3. However, on specific request from you, an additional time of one month can be considered.
