The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for a sum of Rs. 3:000//- (Rupees only) towards Water Supply and Sewerage Infrastructure development charges in his letter dt. 6:598 . With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro water and only after due sanction he/she can commence the internal sewer works.

In respect of water supply, it may be possible for Metro water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the
