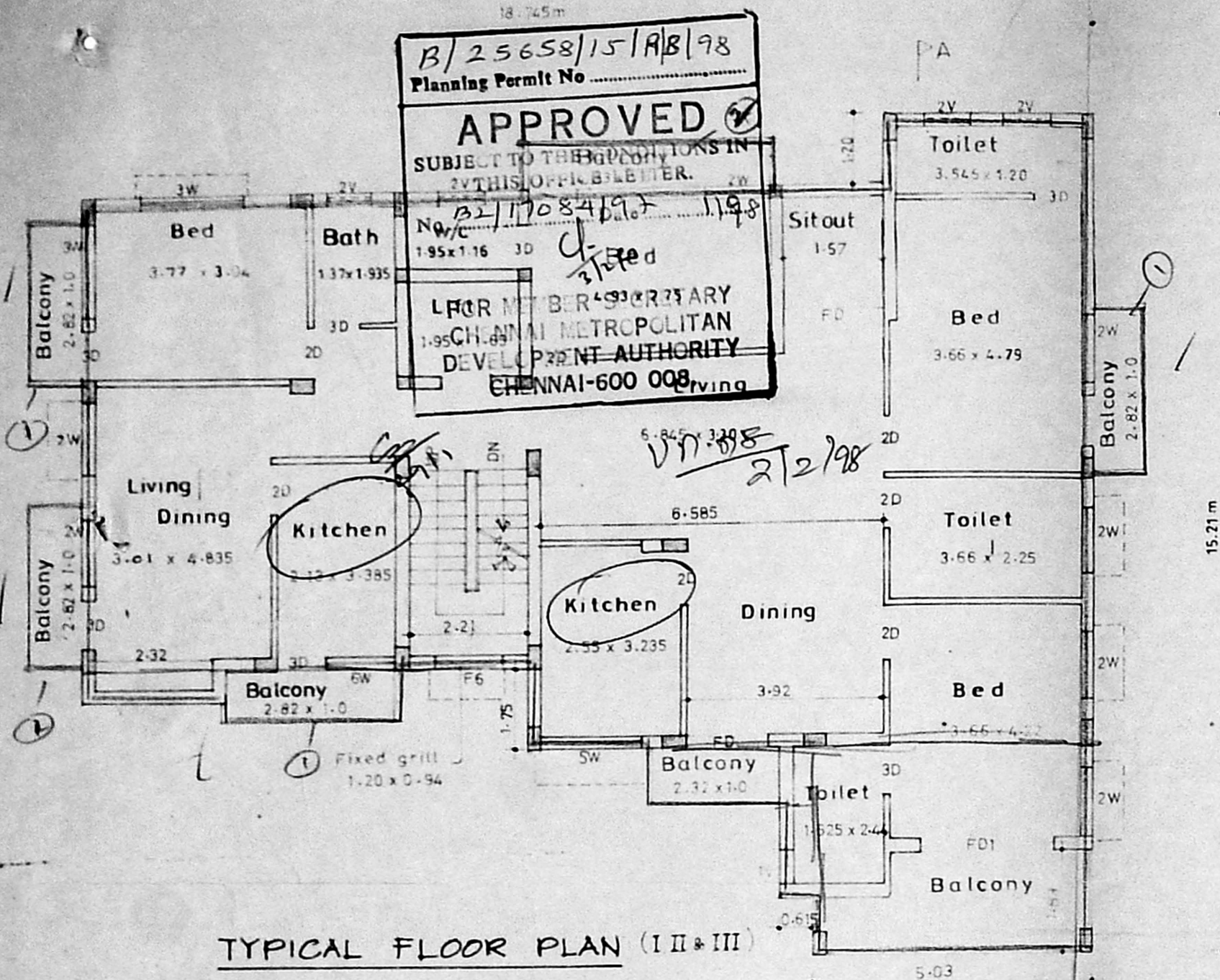
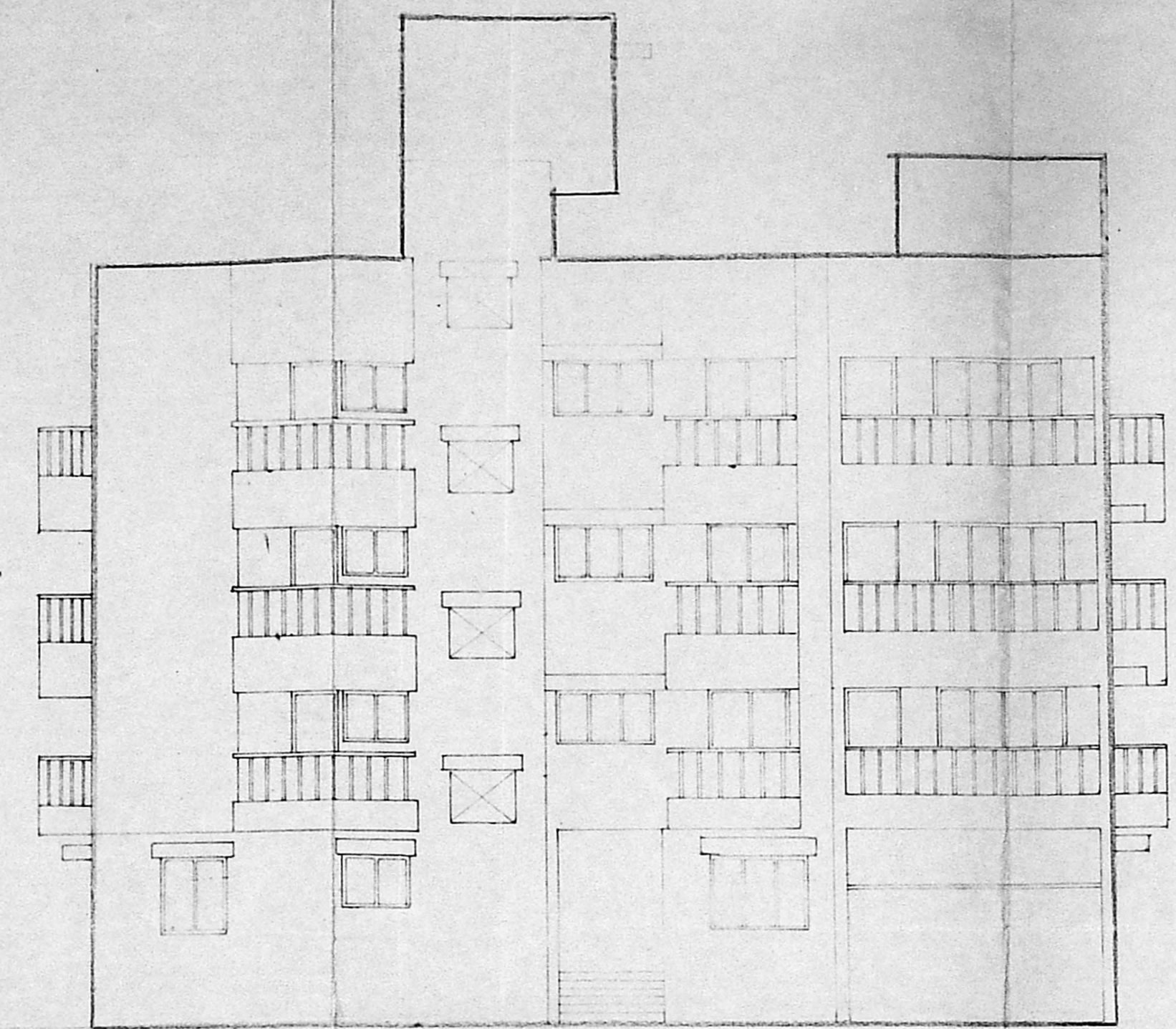

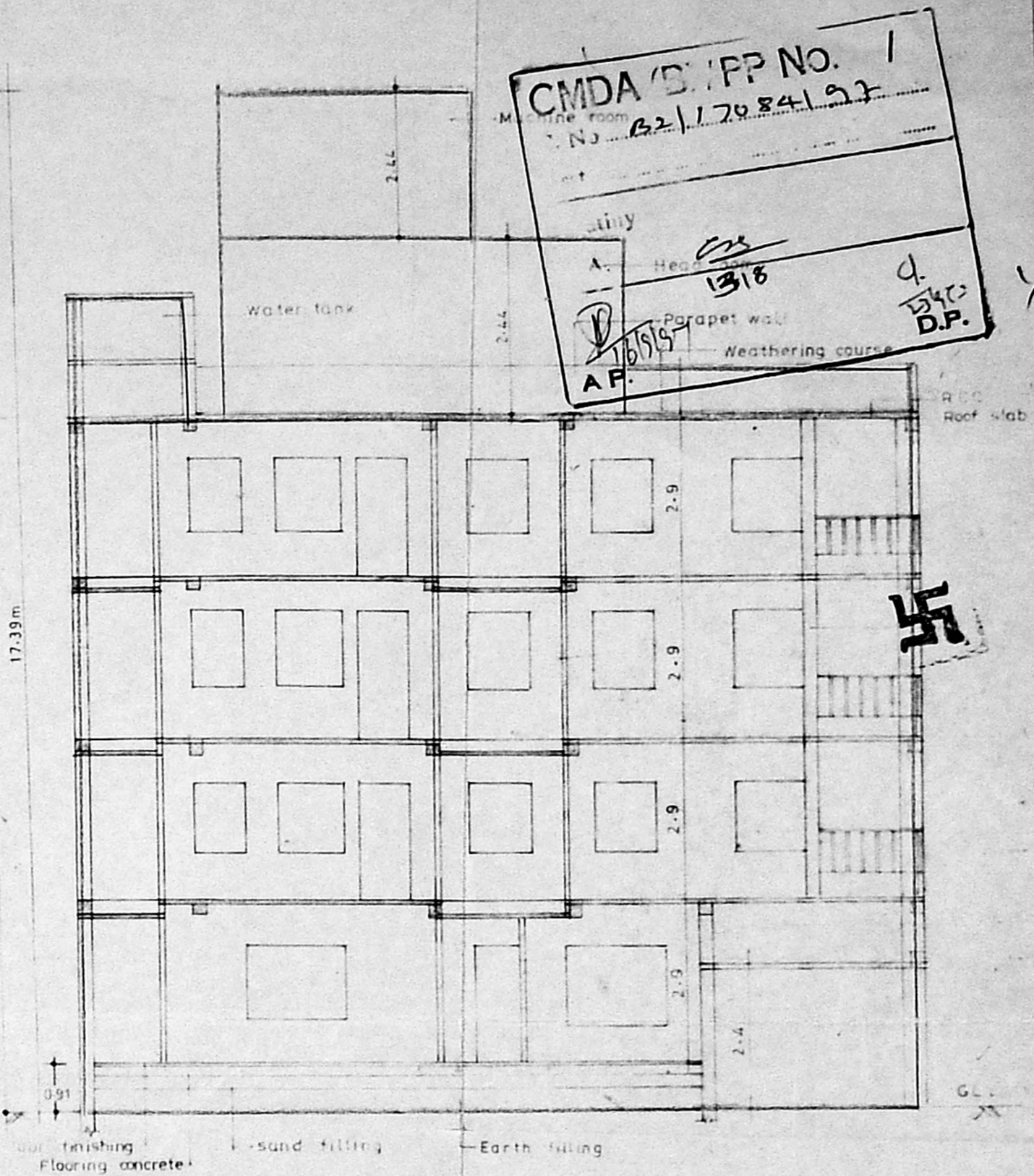

TYPICAL FLOOR PLAN (I & III)

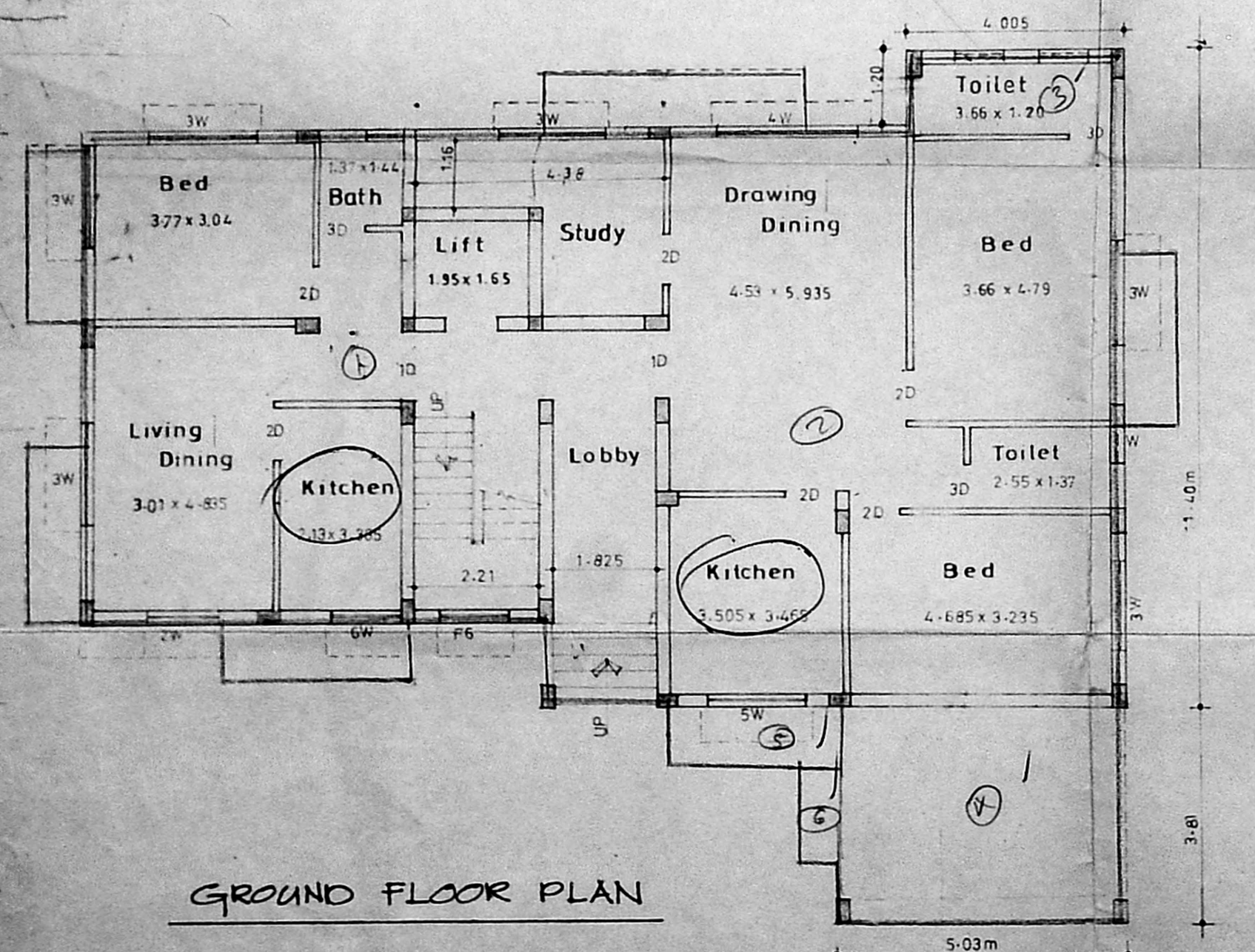

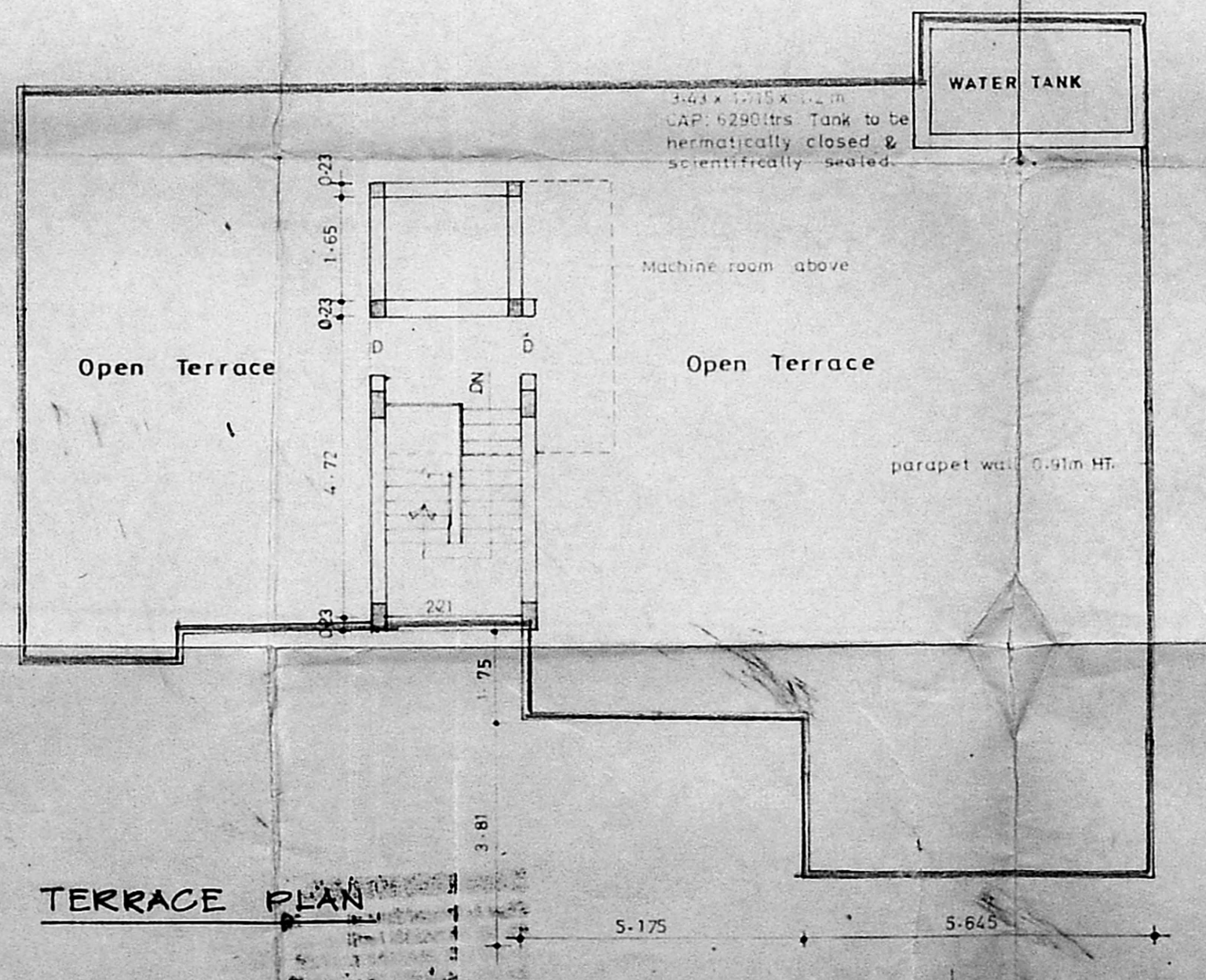
