The planning permission application/Revised plan received in the reference 1st and 3rd cited for the proposed construction of 5 blocks of Ground + 2floor for 30 MIG tenements by Tamilnadu Slum Clearance Board at T.S.No.83, Ward.II, Block No.2 (Phase.II) of Thiruvottiyur village has been approved subject to the conditions incorporated in the reference and subject to the ~~exception~~ condition that the Open Space Reservation/ roads to be handed over to the Local Body within 3 months from the completion of the scheme.

2. The applicant has remitted the necessary charges in Challan No. 87790, dated 3.9.97. Accepting the conditions stipulated by CMDA vide in the reference 3rd cited.

3. The local body is requested to ensure Water supply and Sewerage disposal facility for the proposal before issuing Building Permit.

4. Two copies/sets of approved plans numbered as planning permit No. B/25650/07/A&B/98, dated 22.1.98 are sent herewith. The planning permit is valid for the period from 22.1.98 to 21.1.2001.

5. This approval is not final. The applicant has to approach the Commissioner, Thiruvotriyur Municipality for issue of building permit under the respective local body acts, only after which the proposed construction can be commenced.
