1. The Planning Permission Application/Revised Plan received in the reference 1st & 2nd cited for the construction/development at 2 GF+3F residential building with 9 D.U at Door No. 13 14th main Road, Rajee Annamalai puram Ch-28, RSN: 3953/5 of mylapore division has been approved subject to the conditions incorporated in the Block No. 86 reference 3rd cited.

2. The applicant has accepted to the conditions stipulated by C.M.D.A. vide in the reference 4th cited and has remitted the necessary charges in Challan No. 105214 Dt. 25.11.98 including S.D. for building Rs. 56000 (Rupees fifty six thousand only) and S.D. for Display board (Rupees ten thousand only) and D.D. of Rs. 10,000 (Rs. only) in Cash and / furnished Bank Guarantee No. dt. from Bank Chennai for S.D. for building Rs. (Rupees only) and D.D. of Rs. (Rupees only) as ordered in the W.P.No. dt. This Bank Guarantee is valid till .

3. a) The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for a sum of Rs. 69400/- (Rupees sixty nine thousand four hundred only) towards Water Supply and Sewerage Infrastructure improvement charges in his letter dt. 25.11.98

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements.

In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed of with properly protected vents to avoid mosquito menace.

4. Two ~~copies~~ / sets of approved plans numbered as Planning Permit No. **B/26235/391/98 A&B** dt. **8.12.98** are sent herewith. The Planning Permit is valid for the period from **8.12.1998** to **7.12.2001**

5. This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Locally Body Act, only after which the proposed construction can be commended.
