The planning permission application and Revised plan received in the reference 1st & 3rd cited for the construction of Ground floor + 3floorft. residential building with 14 dwelling units at Door No. 25 & 26, Srinivasan Street, Mandaveli R.S.No. 4124/7 & 8, 4125/23 & 24, Block No. 89, Mylapore, Chennai has been approved subject to the conditions incorporated in the reference 2nd cited.

2. The applicant has remitted the necessary charges in Challan No. 101880, dated 15.5.98 accepting the conditions stipulated by CMDA vide in the reference 5th cited.

3. The applicant has furnished a Demand Draft in favour of Managing Director, Chennai Metropolitan Water Supply and Sewerage Board for a sum of Rs. 1,21,400/- (Rs. One Lakh twenty one thousand and four hundred only) towards Water Supply and Sewerage Infrastructure Improvement charges in his letter dated 14.5.98 & 8.6.98. With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro water and only after due sanction he can commence the internal sewer works.

In respect of water supply, it may be possible for Metro water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed of with properly protected vents to avoid mosquito menace.

4. Two sets of approved plans numbered as Planning Permit No. B/26027/184A to C/98, dated 18.6.98 are sent herewith. The planning permit is valid for the period from 18.6.98 to 17.6.2001.

5. This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the local body acts, only after which the proposed construction can be commenced.
