The planning permission application/revised plan received in the reference first cited for the construction of Ground Floor + 3 Floor Residential Building with 8 Dwelling Unit at Door No.43, Dr. Ramasamy Salai, K.K. Nagar, T.S.No.394/1 part of Kodambakkam has been approved subject to the conditions incorporated in the reference second cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference third cited and has remitted the necessary charges in Challan No.86688, and 86689, dated 8.7.97 and 17.11.98 including Security Deposit for building Rs.42,000/- (Rupees forty two thousand only) and Display Deposit of Rs.10,000/- (Rupees ten thousand only) in Cash.

3. a) The applicant has furnished a Demand Draft in favour of Managing Director, Chennai Metropolitan Water Supply and Sewerage Board for a sum of Rs.50,500/- (Rupees fifty thousand and five hundred only) towards Water Supply and Sewerage Infrastructure Improvement Charges in his letter dated 16.12.98.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction she can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water supply connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed off with properly protected vents to avoid mosquito menace.

4. Two copies/sets of approved plans numbered as Planning Permit No.B/26261/06/99, dated 6.1.99 are sent herewith. The

Planning P permit is valid for the period from 6.1.1999 to 5.1.2002.

5. This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.

In respect of requirements of water for other uses, the promoter has to ensure that he can make suitable arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all water, overhead tanks and septic tanks are hermetically sealed off with properly protected vents to avoid mosquito nuisance.
