The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for a sum of Rs. 53, 200 /- (Rupees only) towards Water Supply and Sewerage Infrastructure development charges in his letter dt. . With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro water and only after due sanction he/she can commence the internal sewer works.
