The planning permission application/Revised plan received in the reference 1st cited for the construction of residential building at Ground Floor + 3Floor with 15 dwelling units at Door No.18, Subbaraya Nagar, 1st Street, in T.S.No. 49/2, Block No.11, Kodambakkam has been approved subject to the conditions incorporated in the reference 2nd cited.

2. The applicant has remitted the necessary charges in Challan No. 102806, dated 27.7.98 accepting the conditions stipulated by CMDA vide in the reference 2nd cited.

3. The applicant has furnished a Demand Draft in favour of Managing Director, CMWSSB for a sum of Rs. 57,600/- (Rs. Fifty seven thousand and six hundred only) towards Metro Water Supply and Sewerage Infrastructure Improvement charges in his letter dated 22.7.98. With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro water and only after due sanction he/she can commence the internal sewer work.

In respect of water supply, it may be possible for Metro water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed off with properly protected vents to avoid mesquite menace.

4. Two copies/sets of approved plans numbered as Planning Permit No. B/26121/277/98, dated 20.8.98 are sent herewith. The planning permit is valid for the period from 20.8.98 to 19.8.2001.

5. This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the local body acts, only after which the proposed construction can be commenced.
