In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and Electrical works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and electric tanks are hermetically sealed off with properly protected vents to avoid seepage water.
