The Planning Permission application/Spec. no. PFA received in the reference 53 cited for the construction/development of 7 plots and proposed building area of plots 1225, 21<sup>st</sup> main Road, Anand Nagar West, 4 R.S. on plot 154<sup>th</sup> of Villambur village has been approved subject to the conditions incorporated in the referenced (1) cited.

2. The applicant has remitted the necessary charges in Challan No. 10/423 dated: 25.2.98 accepting the conditions stipulated by CMIA vide in the spec. no. 78/98 reference and furnished Bank Guarantee for a sum of Rs. 10,00,000/- (Rupees Ten Lacs Only) towards security deposit for building/erector/owner which is valid upto 30 April 2003 (to be paid from Karanda Bank A/c, Karandakhe, Chennai).

3. The applicant has furnished a Demand Draft in favour of M.D. CHEMISE for a sum of Rs. 40,00,000/- (Rupees Forty Lacs Thousand and No Paise Only) towards Water Supply and Sewerage Infrastructure development charges in his letter dt. 24.2.98 & 25.2.98 with reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro water and only after due sanction has been sanctioned the internal sewer works.

In respect of water supply, it may be possible for Metro water to extend water supply to a single pump for the above premises for the purpose of drinking and cooking only and confined to 3 persons per dwelling at the rate of 10 lpd. In respect of requirements of water for other uses, the

promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed off with properly protected vents to avoid mosquito menace.

4. Two copies/sets of approved plans numbered as Planning Permit No. A/16051/207/98 dated: 1-7-98 are sent herewith. The Planning Permit is valid for the period from 1-7-98 to 30-6-2001.

5. This approval is not final. The applicant has to approach the Chennai Corporation for issue of Building permit under the respective Local Body Acts, only after which the proposed construction can be commenced.
