2. The Planning Permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.



- a) Rain water conservation regulations stipulated by CMPA should be adhered to strictly.


5. The issue of Planning Permission will depend on the compliance/fulfilment of the conditions/payments stated above.


