2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.



a) Rain water conservation regulations stipulated by CMDA should be adhered to strictly.


5) The issue of Planning Permission will depend on the compliance/~~fulfilment of the conditions~~/payments stated above.
