Sub: CMDA - Planning Permission - Proposed construction of Stilt parking floor + 4 floors residential building with 6 dwelling units at Door No. 16, Porur Somasundaram Street, T.Nagar, Chennai-17, T.S.No. 8000, Block No. 107, T.Nagar Division - Approved.

The planning permission application received in the reference 1st cited for the construction of Stilt parking floor + 4 floors residential building with 6 dwelling units at Door No. 16 Porur Somasundaram Street, T.Nagar, Chennai-17, T.S.No. 8000, Block No. 107, T.Nagar Division has been approved subject to the conditions incorporated in the reference 4th cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 5th cited and has remitted the necessary charges in Challan No. 1666 dt. 23.9.99 including Security Deposit for building Rs. 56,000/- (Rupees fifty six thousand only) and Display Deposit of Rs. 10,000/- (Rupees ten thousand only) in Cash.

3. a) The applicant has furnished a Demand Draft in favour of Managing Director, Chennai Metropolitan Water Supply and Sewerage Board for a sum of Rs. 70,100/- (Rupees seventy thousand and one hundred only) towards Water Supply and Sewerage Infrastructure Improvement Charges in his letter dt. 23.9.99.

B) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirement of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed of with property protected vents to avoid mosquito menace.

4. Two sets of approved plans numbered as Planning Permit No. B/27035/279/99/A&B, dt. 14.10.99 are sent herewith. The Planning Permit is valid for the period from 14.10.99 to 13.10.2002.

4. This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
