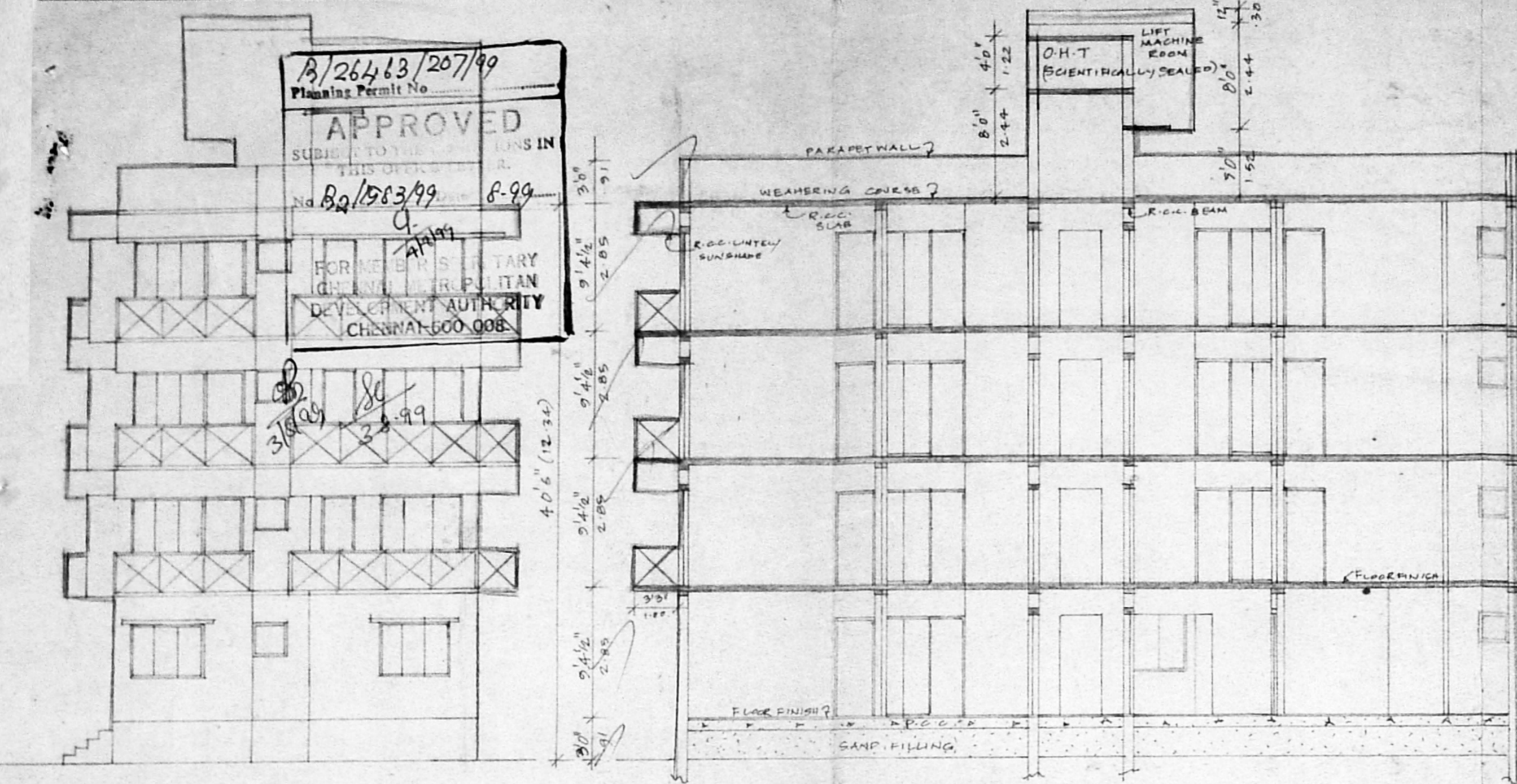
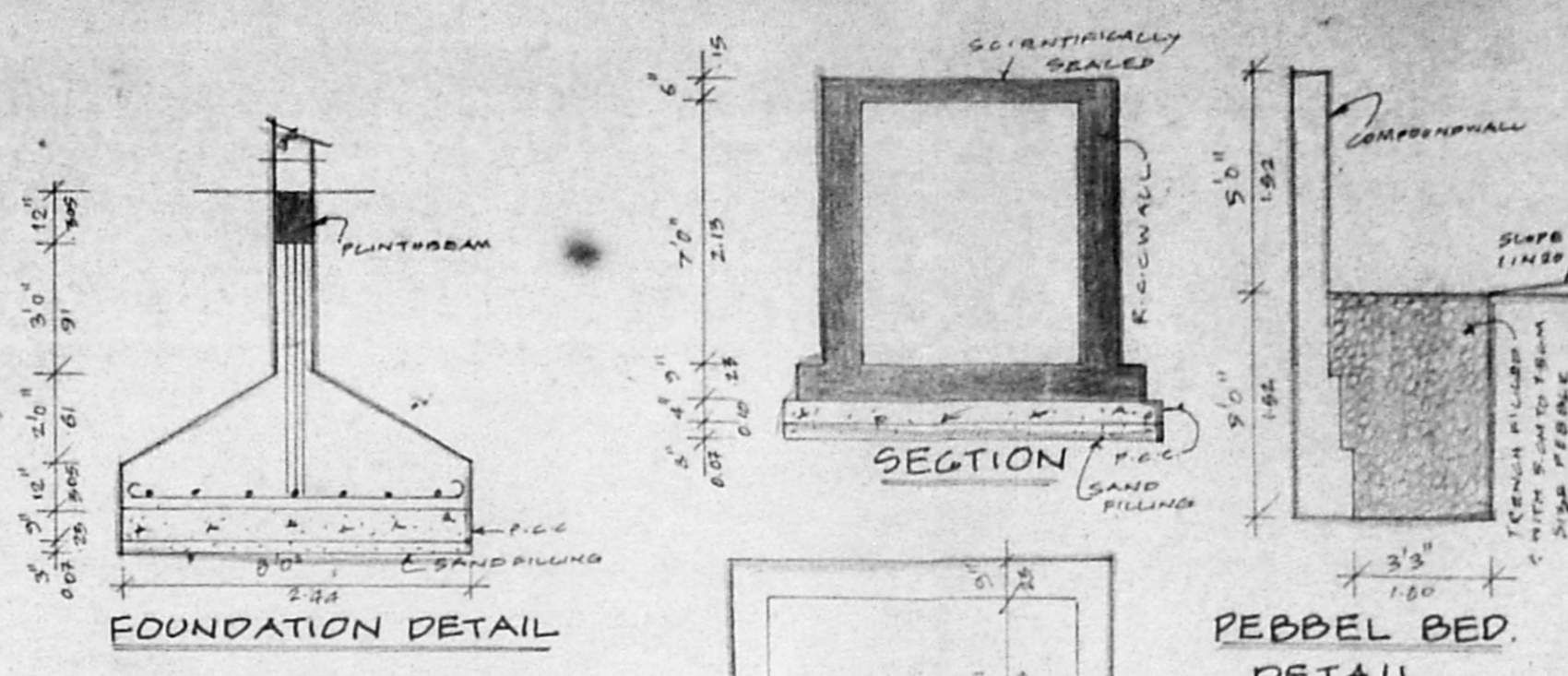

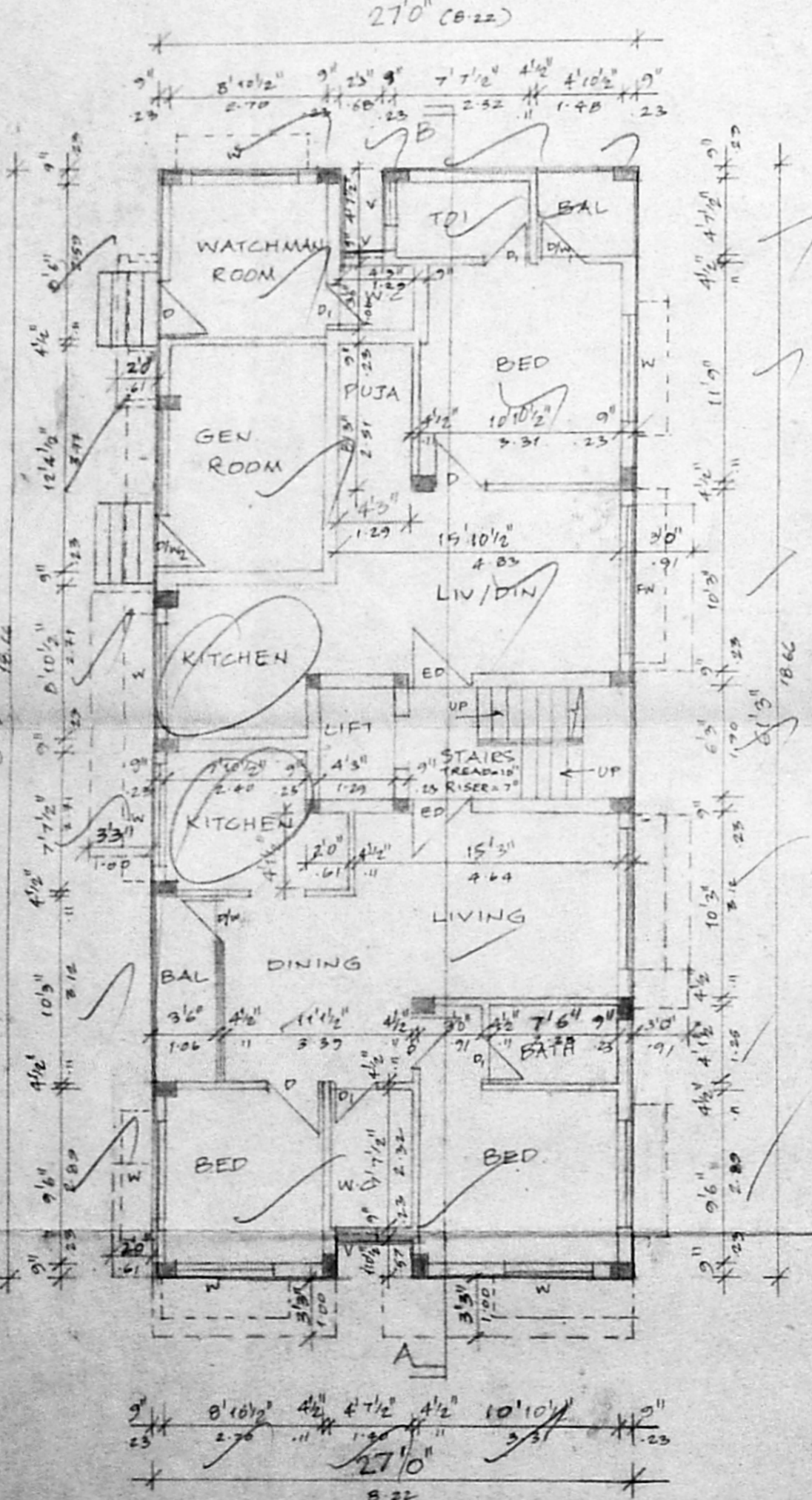

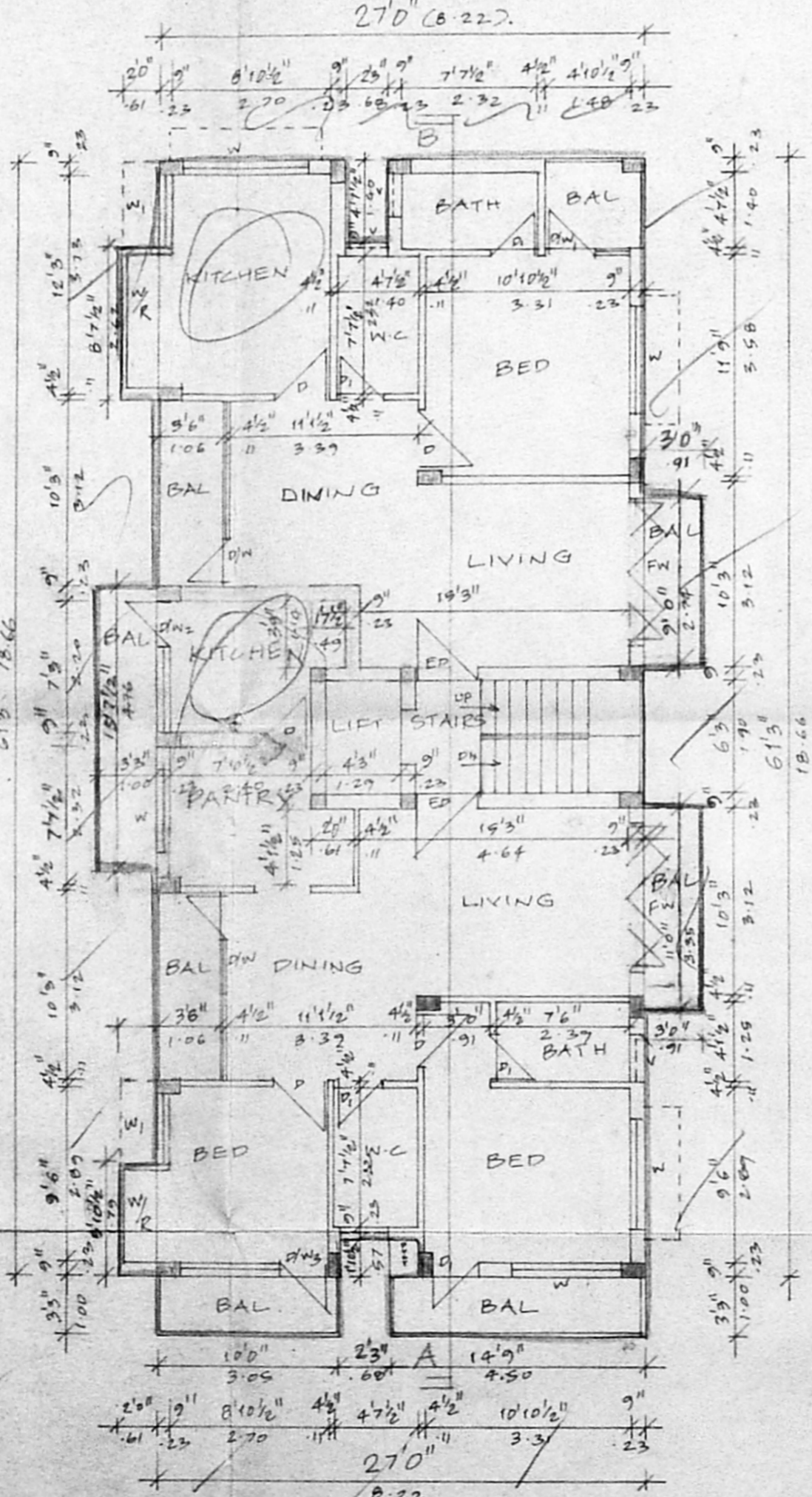

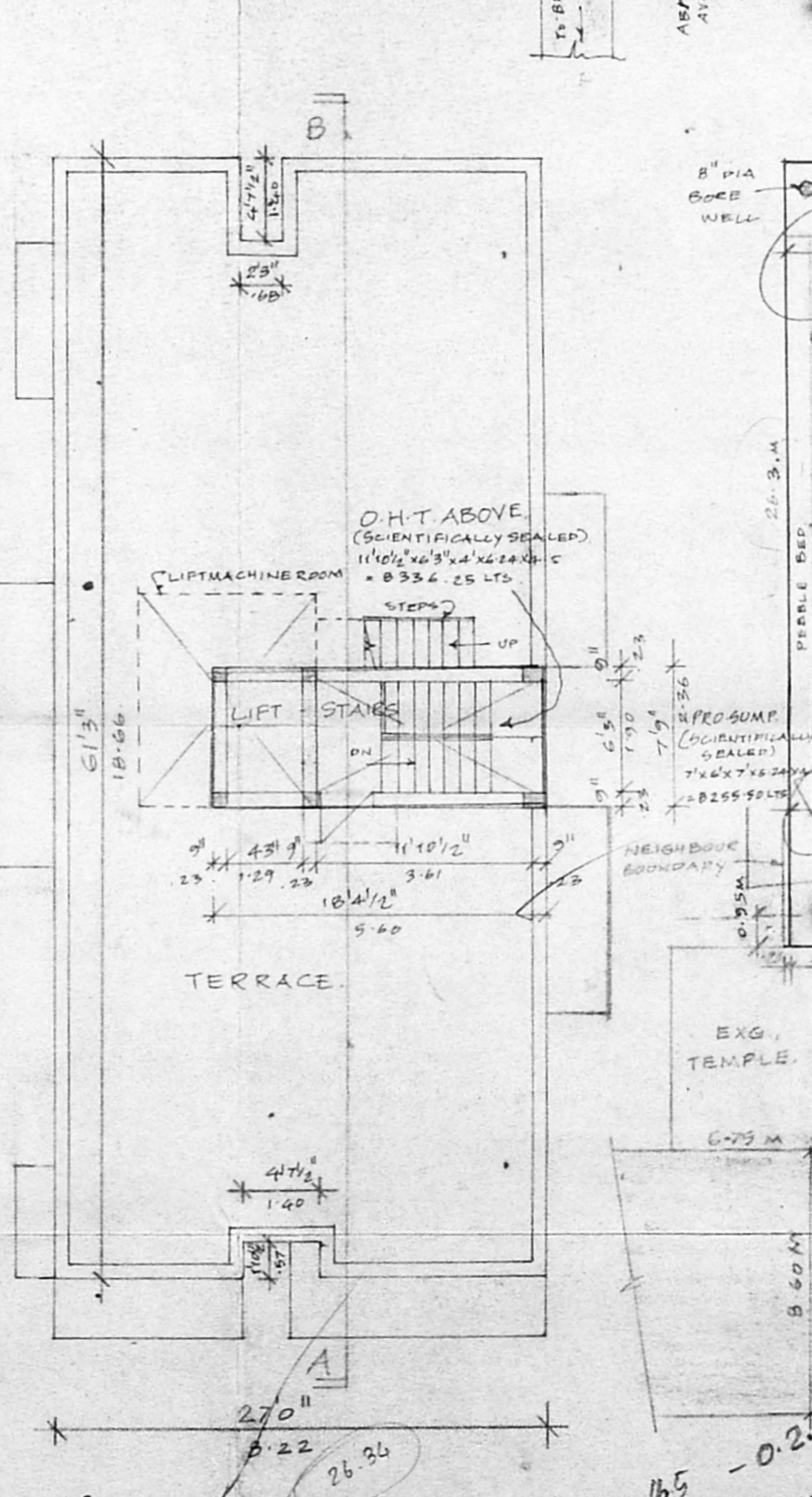

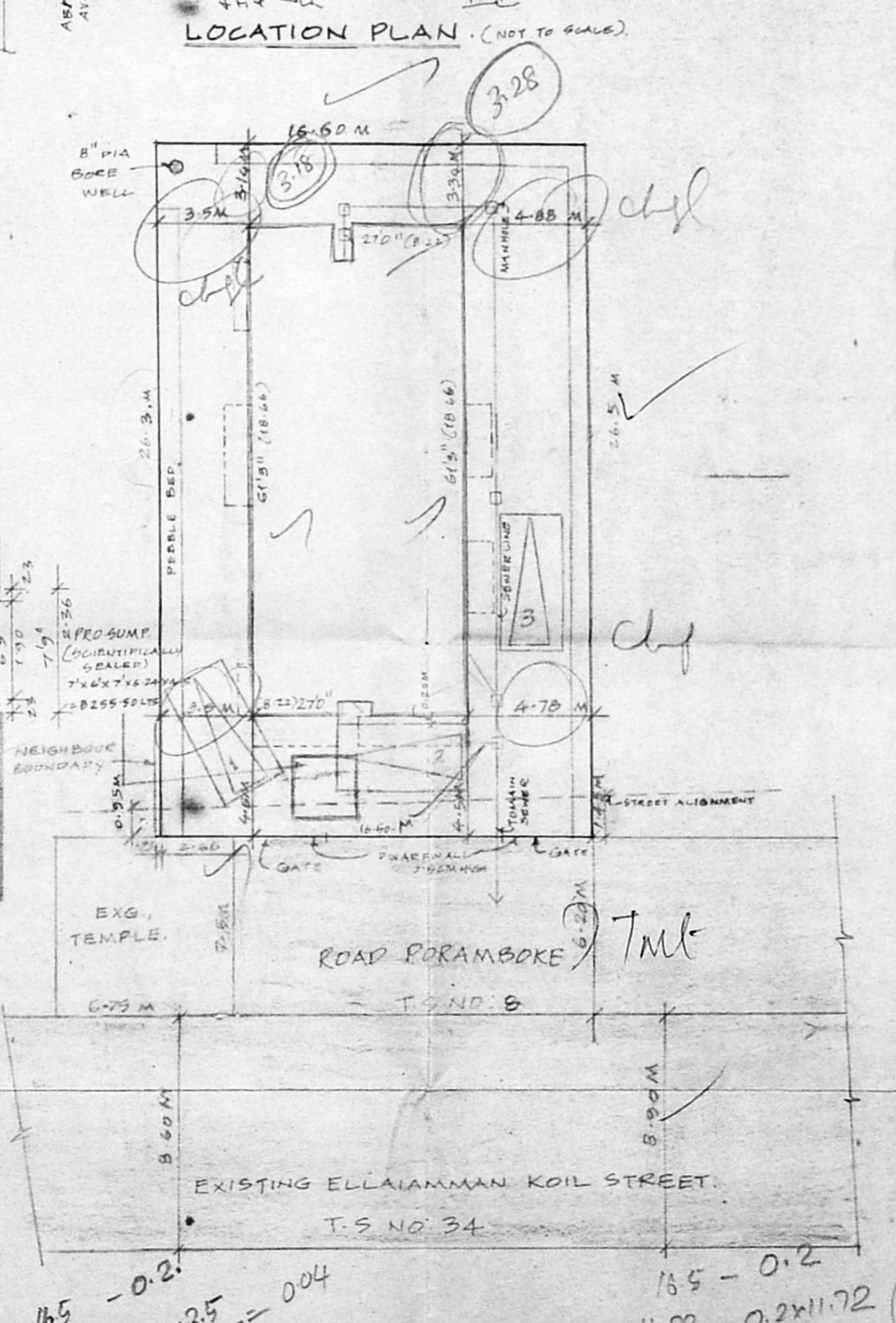
GROUND FLOOR PLAN
