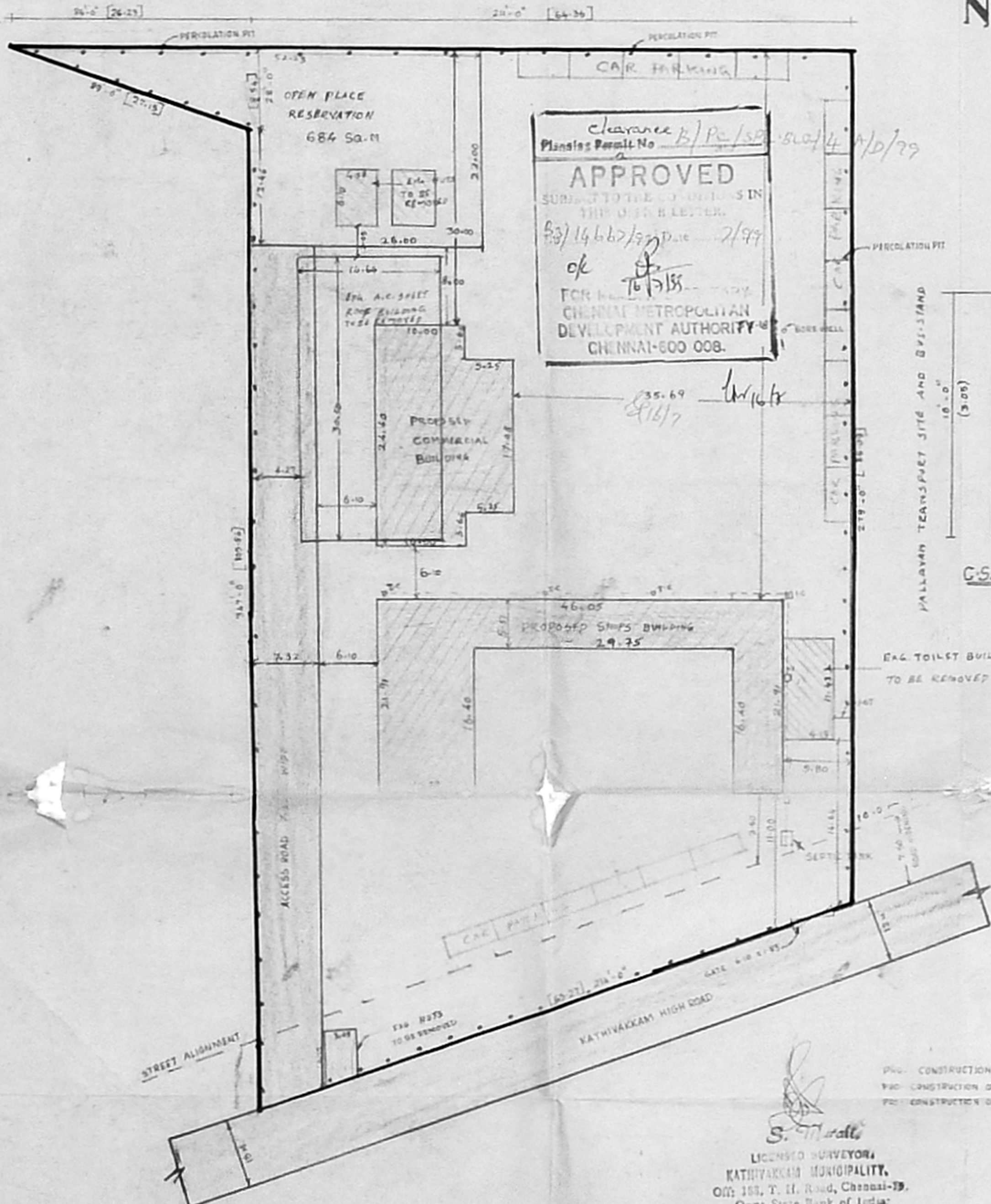

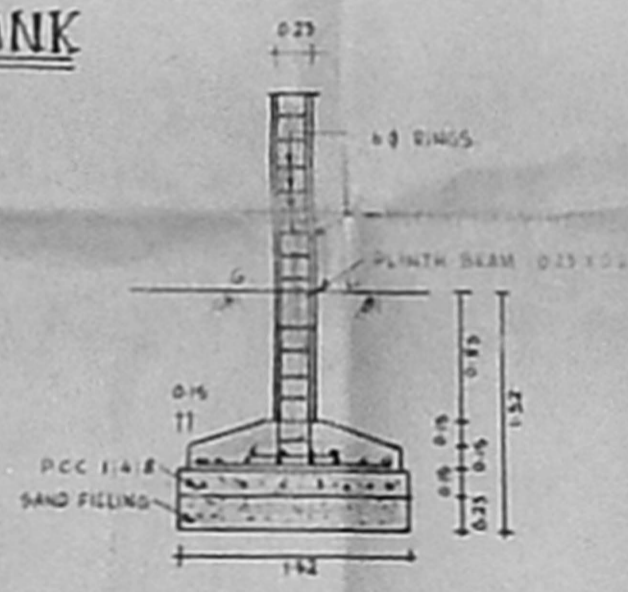
SEG. OF SEPTIC TANK
