1. The Planning Permission Application/Revised Plan received in the reference first cited for the construction/development of G+3F Resl. quarters for 216 D. units by TNPDC at T.S. no. 66, B. No. 9 of Siruwallur village has been approved subject to the conditions incorporated in the reference, 2nd cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 3rd cited and has remitted the necessary charges in Challan No. 0662 Dt. 12/9/2000 including S.D. for building Rs. 4,90,000/- (Rupees Four lacs and ninty thousand only) and D.D. of Rs. 10,000/- (Rupees Ten thousand only) in Cash and towards display deposit furnished Bank Guarantee No. _____ dt: _____ From _____ Bank _____ Chennai for S.D. for building Rs. _____ (Rupees _____ only) and D.D. of Rs. _____ (Rupees _____ only) as ordered in the W.P.No. _____ dt: _____ This Bank Guarantee is valid till _____

3.a) The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for a sum of Rs. 6,24,000/- (Rupees Six lacs and Twenty Four thousand only) towards Water Supply and Sewerage Infrastructure improvement charges in his letter dt: 12/9/2000

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro. Water and only after due sanction he/she can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of

water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the Promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed of with properly protected vents to avoid mosquito menace.

4. Two copies/sets of approved plans numbered as Planning Permit No. B/spl. 666/366 A to C dt: 11/2000 are sent herewith. The Planning permit is valid for the period from 11/2000 to 11/2003

5. This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
