 - ii) In cases of Special Buildings, Group Develorments a professionally qualified Architect
 Registered with Council of Architects or Class-I
 Liounsed Surveyor shall be associated with the
 construction work till it is completed. Their
 names/addresses and consent letters should be
 furnished.
 - iii) A report to writing shall be sent to Chennai
 Metropolitan Development Authority by the Architect/
 Class-I Licensed Surveyor who supervises the
 construction just before the commencement of
 the erection of the building as per the sanctioned
 plan similar report shall be sent to Chennai
 Metropolitan Development Authority when the

- ix) If there is any false statement, suppression or any mis representations of acts in the application, planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.

- xii) Rain water conservation measures notified by CMDA should be adhered to strictly;
